**REPLY TO GOVERNMENT'S OPPOSITION TO MOTION FOR CHANGE OF VENUE
AND INCORPORATED MEMORANDUM OF POINTS AND AUTHORITIES IN
SUPPORT THEREOF**

In its opposition to Mr. Guandique's Motion for a change of venue, the government contends that Mr. Guandique failed to demonstrate any factual basis for the requested change of venue. Gov't Opp at 6.

However, the attached affidavit from Matt Glassman, Senior Producer of Content at WRC Channel 4, a local television station that covers the greater Washington metropolitan area, makes clear that between May and September 2001, the seven daily news programs on WRC Channel 4 aired daily stories on the Chandra Levy case. *See* Exhibit A (February 16, 2010) Affidavit of Matt Glassman) (appended hereto). Thereafter, and until May 2002, WRC Channel 4 did periodic updates on the case. *Id.* In May 2002 (at the time of the discovery of the remains purported to be the decedent's), again the station aired daily coverage about the Chandra Levy case. *Id.* In the years between 2002 and 2009, the station aired periodic updates on the Chandra Levy case when events such as the anniversary of her disappearance, or her parents' visits to the District of Columbia occurred. *Id.* Finally, from April, 2009, through February, 2010, WRC Channel 4 has mentioned Ingmar Guandique's name 86 times. *Id.*

Consistent with the affidavit from Matt Glassman, Philip Metlin, Custodian of Records from WTTG (Fox 5 News) has provided a 28-page listing of all the stories about the Chandra

Levy case aired on WTTG between May 10, 2001, and February 18, 2010. *See* Exhibit B (appended hereto). There also has been extensive print media coverage of the case, including a thirteen-part series in the Washington Post that ran from July 13 through 28, 2008. In short, the publicity surrounding this case has been far greater in the District of Columbia than elsewhere, and for the reasons set forth in his February 12, 2010, Motion for Change of Venue, Mr. Guandique continues to seek a trial in another jurisdiction.¹ While the government contends that this case has received nationwide media attention, Gov't Opp. at 1, unquestionably the frequency, concentration, and depth of news coverage has been far greater in the District of Columbia than in other parts of the United States.

Without waiving his request for a change of venue, in the event the Court denies that remedy, in the lesser alternative, and as suggested by the government's opposition, Mr. Guandique requests a combination of measures to mitigate the tremendous and extreme publicity that has attended his case. Notably the government states more than once that there are lesser remedies than a change of venue to address the media attention that has attended Mr. Guandique's case. *See* Gov't. Opp. at 1 (referencing "effective administration of *voir dire* by the Court with assistance from the parties"), 5 (citing, *inter alia*, a "careful *voir dire*, and citing "extensive and careful *voir dire* procedure"), 6 ("careful *voir dire* procedures").

¹The government takes issue with the failure of undersigned counsel to have suggested a specific *situs* for the trial. Gov't Opp. at 6. Had Mr. Guandique suggested an alternate venue, the government then would have attacked him for having had the temerity to make a request for a specific location for his trial. Rather than seeking a specific venue, Mr. Guandique seeks a trial in a venue that is not, and has not been, as saturated with publicity about this case as the District of Columbia is and has been.

Specifically, as has been done in cases in this jurisdiction² and many other local and federal courts across the country, Mr. Guandique requests summoning a special and significantly larger than usual *venire* dedicated solely to this case (and not simply utilizing any jurors who may have been summoned for the date on which jury selection in this case commences). He further requests the use of two juror questionnaires, one a preliminary qualifying questionnaire, and the second a questionnaire to be used only with those jurors deemed qualified based upon the responses received to the first questionnaire, with each of the two questionnaires to be jointly submitted by the government and the defense. Finally, Mr. Guandique requests individual lawyer-conducted *voir dire* and additional preemptory strikes for each side.

All of the foregoing lesser remedies to lessen the prejudicial impact of excessive pretrial publicity have been used in numerous other state and federal cases across the country where pretrial publicity has been an issue. *See e.g. Oswald v. Bertrand*, 374 F.3d 475 (7th Cir. 2004)

(jury questionnaires mailed to 156 county residents, individual *voir dire* and additional preemptory challenges); *Casey v. WHEREFORE for the foregoing reasons, those set forth in his February 12, 2010, Motion and any reasons that might appear at a hearing on this motion, Mr. Guandique

respectfully moves this Court for entry of an order changing the venue of the trial to a location that would allow selection of jurors not prejudiced by the sensational local pretrial publicity that has attended his case. In the lesser alternative he requests the *voir dire* procedures set forth in the body of this reply.

AFFIDAVIT


I, Matt Glassman, by my signature below, hereby declare under penalties of perjury that the following is true and correct to the best of my knowledge:

1. I am the Senior Producer of Content at WRC Channel 4, in the District of Columbia, the local NBC owned and operated television station. WRC Channel 4 covers the greater Washington, D.C. metropolitan area. Through my position, I contribute to the overseeing coverage of local news in the greater Washington D.C. metropolitan area.
2. I am generally aware of WRC Channel 4's coverage of the Chandra Levy case and of Ingmar Guandique.
3. Between May 2001, when Chandra Levy disappeared, and September 11, 2001, a majority of WRC Channel 4's weekday news shows (of which there are seven), aired stories daily regarding the Chandra Levy case.
4. Between September 11, 2001, and the discovery of Ms. Levy's remains in May 2002, WRC Channel 4 did periodic updates on the Chandra Levy case.
5. For a few days in May 2002, upon the discovery of Chandra Levy's remains, WRC Channel 4 again aired coverage of the case.
6. Between May, 2002, and 2009, WRC Channel 4 continued to air reports about the Chandra Levy case on events relevant to the case such as when her parents came to the District of Columbia and on the five-year anniversary of her disappearance.
7. My review of our scripts from April 2009 to the present, WRC Channel 4's coverage of the Chandra Levy case and of Ingmar Guandique indicates that Ingmar Guandique has been mentioned approximately 86 times on WRC Channel 4 news programs.
8. I am making this affidavit in response to and in satisfaction of a subpoena issued upon WRC Channel 4 by the defense in the above captioned action. By submitting this affidavit, I do not waive and expressly preserve any objections to the subpoena and/or privileges WRC Channel 4 may have.


DECLARATION OF CUSTODIAN OF RECORDS
